### NOTICE INVITING EXPRESSION OF INTEREST

Managing Director, West Bengal Livestock Development Corporation Limited invites 'Expression of Interest' from the interested businessman/ organization/ company / proprietorship or partnership firm **having experience in Contract Farming / Goat farm Integration** for working as implementing agency for procurement of Pure Black Bengal Goat (in male : female 1:10 ratio), distributing them among farmers for breeding & rearing and supplying live goats at their marketing age (12 months approx.) weighing up to 14-16 kg, at **Haringhata Meat Plant**, Nadia on contract basis and submit their offer in the prescribed format within **17<sup>th</sup> January, 2018 up to 05:00 PM**. The details papers including the application form can be availed from the Office of the undersigned at LB-2, Sector-III, Salt Lake City, Kolkata-700106 on payment of a cost of **Rs. 100/- (Rupees One Hundred) only** in cash on or before **17<sup>th</sup> January, 2018 up to 05:00 PM**.

## GENERAL TERMS & CONDITIONS

1. Company/Firms/LLP/Proprietorship Concerns having experience in similar nature of work are eligible to participate, directly or through their sponsored entity, be it a company, firm or LLP provided they fulfil the following conditions:
  - a. Sponsored participating bidders must furnish authorization from its sponsoring entity.
  - b. Minimum Average annual turnover of the applicant or of the sponsoring unit of **Rs. 5.00 Lakhs or more** as a whole in each of the last 3 (Three) financial years.
2. The bidder should invariably quote their offer only at specified space in the application form for **'Monitoring & Supervision charge (INR)** per kg of live goats to be supplied by them at Meat Plant, Haringhata, Nadia.
3. The application along with supportive documents in **sealed cover** super-scribed as **'Application for Goat Contract Farming against EOI Notification No. - No.- LDC-EOI/2017-18/3102; Dated:- 27<sup>th</sup> Day of December, 2017'**; must be dropped in the Tender box, kept at the office of the undersigned on or before **17<sup>th</sup> January, 2018 up to 05:00 PM.**
4. The EOI documents will be opened & evaluated by the Tender Selection committee of this corporation on **18<sup>th</sup> January, 2018, 11:00 AM or afterwards.**
5. The application fee (Rs. 100/- only) is to be deposited in Cash at the office of the undersigned for drawing the application form and it is not refundable to the bidder under any circumstances.
6. L1 bidder among the qualified & valid participants will be awarded in due course of time.
7. The period of agreement will be initially for **1 year** which may further be extended up to **another 1 year** depending upon the performance of the agency.
8. Before or at the time of entering of this contract the second party shall have to furnish a security deposit of **Rs. One lakh only** in form of a bank draft drawn in the favour of **WEST BENGAL LIVESTOCK DEVELOPMENT CORPORATION LIMITED**, The First Party, and payable in Kolkata. The Security Money will be refunded to the agency after successful completion of the work for specified period.
9. The agency will purchase the **Pure Black Bengal Goats parent stock in 1:10 ratio (male: female)** from empanelled agency / firm as per instruction of the Corporation and submit the bill to the First Party at the end of each month for reimbursement by the Corporation.
10. The Second Party will supply the parent stock of goats to the beneficiaries at village level/ Farmers of Nadia and its neighboring districts (up to 50 km radius or such extent from where transportation of slaughterable goats seems feasible to the agency) by the second party at its own cost.
11. The selection of Farmers /SHG or any others groups at village level for rearing of goats will be solely matter of choice of the Second Party and the Corporation/ First Party will not be liable to mitigate any loss or risk arising there-from under any circumstances. However, the agency must prepare a database of the selected beneficiary and send it to the office of the undersigned time to time, as amended, for necessary approval & record keeping in this end.
12. Insurance of live goats will be covered @ 5% of their purchase value.
13. The selected individual / SHG will be supplied with 10 breedable does and 1 breeding bucks of 1-1.5 years of age and will be provided with **concentrate feed** (for 60 days in a year), vaccines, medicines, and other relevant activities as required.

14. Necessary feed cost, medicine, vaccine and other veterinary care will be borne by the Second Party to meet up the day to day requirements of the Farmers, each of which will be limited by a higher ceiling as per following calculation –

**Considerations:-** \*1. Bucks & Does will be fed concentrate for 2 months in a year and kids for 1 month in a year. For rest of the months farmers have to feed the animals on grazing field on their own.

\*\*2. Out of 10 breeding does, 9 will give birth of 9 × 2 = 18 kids (1:1) per gestation period (5 months) i.e. 18 × 1.5 = 27 kids per year (considering no. of kidding per year = 3 in 2 year or 1.5 in a year) or less 15% mortality = **23 live kids in a year.**

15. The empanelled agency will produce bills of feed, medicine, vaccine or vitamins/ minerals etc. under their letterhead showing item-wise break-up and always keeping the higher ceiling as shown above.

16. Cost of rearing **@ Rs. 10/- per live kg of goat** will be provided to the farmer up to attainment of 14-16 kg body weight of goats. This cost also shall be borne by the Second Party initially which may be reimbursable by the Corporation.

17. A total of 100 units (consisting of 10 female & 1 male adult goats) will be distributed in several uniform batches in consequent months so that saleable goats will be available in constant way.

18. **The male kids** from the breeding stock will be bought back at a pre fix age (approx. 12 months) and pre fix rate (**half of market price**). Present market price of male goat – Rs. 230/- per live kg.

19. Female kid will become the property of farmer / SHGs, but inbreeding is to be strictly prohibited. **Change of stock or sell may be considered in this regard.**

20. **Theft and burglary of the goats/kids** must be prevented by the Farmer / SHG members themselves & Agency in joint effort, and in case of any report of theft, the matter will be treated as per law and the **agency** will be held responsible for that with due reimbursement, and this will be deducted during buyback system. The recurrent incidence of theft may terminate the project.

21. In case of death of any kid/goat, farmer has to produce the dead body to the agency / corporation for Insurance claim.

22. If the Second Party **fails to deliver** in accordance with one or more work order(s) within the stipulated date and time the Corporation, to maintain its production, may procure goats from the open market at Govt. rate/rate contract with any third party & the rate difference will be charged on the Second Party and may be recovered either from its bill and/or security money deposited by the Second Party in terms of the condition rest at **clause no. 8**.

23. Pre-slaughter health certificate of goats issued by qualified veterinarian, stating that goats are 'fit for slaughter & human consumption', should be supplied with the each consignment.

24. Weight of live and healthy goats will be taken at the time of delivery at Haringhata Meat Plant and **payment of agency commission will be made on that live weight basis.**

25. All the Payment will be made only after receiving the stock & satisfactory notes from In-Charge, Haringhata Meat Plant.

26. No advance payment will be allowed normally.

27. Goats should weigh in the range of 14 to 16 kg. Continuous aberration from this standard range may attract penal provisions and necessary steps may be taken against the Second Party.

28. If there is any dispute regarding any of the terms of this Agreement or regarding any other issues directly relating to this Agreement, the matter may first be tried to be mutually resolved by the parties failing which matter will be referred to arbitration in accordance with the Arbitration Act, 1996.

29. All matters in this respect will come within the jurisdiction of Calcutta High Court.

The decision of the evaluation committee will be final in this regard. The committee reserves all the right to reject any or all the Agencies applying without assigning any reason thereof.
