The entrusted person / agency / firm will sell the frozen meat items of 'Haringhata Meat' to the customers' point under his jurisdiction on fixed commission as per agreement. Corporation will consider to let him use an especially designed 'e-RICKSHAW WITH MODIFIED STRUCTURE, CANOPY, BATTERY, WIRING, VENDING FREEZER AND OUTSIDE BRANDING WORK' for the purpose for smooth functioning of his business.

GENERAL TERMS & CONDITIONS

1. Interested & Eligible individuals / Company/ Firms/ LLP/ Proprietorship Concerns preferably having experience in similar nature of work are eligible to participate, directly or through their sponsored entity, be it a company, firm or LLP provided they fulfil the following conditions. Sponsored participating bidders must furnish authorization from its sponsoring entity.
2. The filled in application along with enclosures must reach to the office of the undersigned in sealed envelope super-scribed as **'APPLICATION FOR E-RICKSHAW FITTED WITH 200 LITRE DEEP FREEZER IN-BUILT FOR MARKETING OF HARINGHATA MEAT ON LICENSE BASIS-2nd Call**; mentioning Notification No. & Date of this advertisement, on or before **31.10.2018; 05:00 PM**.
3. The sealed applications along with other documents will be opened & evaluated by the Selection committee of this corporation on **01/11/2018; 11:00 AM or onwards**.
4. The application fee (**Rs. 100/- only**) is to be deposited in Cash at the office of the undersigned for drawing the application form and it is not refundable to the bidder under any circumstances.
5. The period of agreement will be initially for **1 year** which may further be extended up to **another 1 year** depending upon the performance of the concern.
6. Before or at the time of entering of this contract the selected party shall have to furnish a security deposit of **Rs. 25,000/- (Rupees Twenty Five Thousand) only** in form of a bank draft drawn in the favour of **'WEST BENGAL LIVESTOCK DEVELOPMENT CORPORATION LIMITED'**, payable at Kolkata. The selected party must enter into a contractual agreement with this corporation. The Security money will be refunded back to the party after expiry of the validity of service tenure for specified period. The Security money will not carry any interest.
7. The selected party shall have to apply for 'Dealership Silver category' of 'Haringhata Meat' against a non-refundable payment of **Rs. 5,000/- (Rupees Five Thousand) only** as 'One-Time Registration Fees'.
8. The agency shall be entitled to boost the marketing of 'Haringhata Meat' products under his jurisdiction and in this context a **target of minimum Sale volume of Rs. 50,000/- per month** must be achieved for continuation of his franchisee for next year. However, this sale target may be revised from time to time and may differ area-wise. Decision regarding the same will always be at the sole discretion of the Managing Director, W.B.L.D.C.Ltd.
9. **A monthly license fee of Rs. 2,000/- (Rupees Two Thousand) only**, payable to this corporation through Cash/ DD in f/o- 'W.B. Livestock Development Corporation Ltd.' have to be deposited within **07th day** of each subsequent month positively, failing to which may invite cancellation of the contract & withdrawal of the e-Rickshaw from that particular vendor.

10. The selected party shall be liable to conduct his business within the stipulated area of coverage as will be marked by the corporation.
11. The maintenance & other misc. costs for running the e-rickshaw to be borne by the party himself. However, in case of major damage / accidental loss etc., where insurance coverage are to be made, the incident must be brought to the notice of the undersigned immediately for taking necessary course of action.
12. In case of continuous unsatisfactory performance of the vendor, the corporation may terminate his dealership / vendorship without any notice and the e-rickshaw will be taken back from him. Any mechanical or physical loss / damage other than depreciation loss shall be adjusted from the security deposit and any decision regarding this adjustment shall be under sole discretion of Managing Director, W.B.L.D.C. Ltd.
13. The e-Rickshaw distributed within the jurisdiction of Kolkata Municipal Corporation, shall have to obtain the Haringhata Meat & Meat products on cash payment from Central Store, Belgachia, or from nearest outlet as directed by the authority as will be decided time to time. However, he/she will be entitled to get the benefit of Haringhata Meat **Dealers' commission** for all the products. For other than Kolkata Municipal Corporation and Greater Kolkata area, the replenishment / supply of order will be made by the Corporation's own management / or through its any entrusted agency / or from any nearest outlet of Haringhata meat, as will be directed from time to time.
14. The appointed Vendor must have their office on a prominent place/or **sufficient go-down space** at any approachable area and must have **Trade & other required Licenses** in his/her/their name of selling the Food Products, where the e-Rickshaw along with Haringhata Products could be kept safely.
15. Application for e-Rickshaw will have to be made along with attested copies of Address Proof of the signatory authority, Photo Identity Proof, Telephone No. etc.
16. As per the directives of FSSAI authority, under Govt. of India, an online application for *fssai* ('**registration only**') is to be made at <https://foodlicensing.fssai.gov.in/index.aspx>, by the Applicant before issuance of the vendorship.
17. The selected party shall have to abide by the terms & conditions as will be laid down by the Corporation time to time.
18. Each selected Vendor will place a firm indent to West Bengal Livestock Dev. Corpn. Ltd. on the date of supply indicating his requirement for the next supply.
19. All products will be supplied subject to the availability in stock on the specified date of supply in standard packaging only.
20. Products will be supplied to the Vendor (s) on specified date preferably between 9.00 A.M. to 5.00 P.M. the date and time of delivery is subject to change due to unforeseen reasons.

21. All products are to be kept properly at -18 °C till it reaches to the end users / consumer.
22. The stock of the Vendor (s) will be liable for inspection by the Authorized Representative(s) (of W.B.L.D.C.Ltd. as and when required.
23. Product/Products once sold will not be taken back.
24. Any rejection should be done on spot delivery of the products and should be returned to W.B.L.D.C.Ltd.
25. In case of any unfair means adopted by the vendor, his/her/their vendorship may be terminated without showing any reason thereof and further legal action may be initiated against him, if felt necessary.
26. In respect of any dispute or any point arising out of the above, decision of the Managing Director, W.B.L.D.C.Ltd. will be final and binding upon the Vendor.
27. Disputes if any, may be resolved mutually, if not, it may be referred to sole arbitrator, the Chairman of the Corporation or his nominated representative not below the rank of Deputy Secretary be the sole arbitrator for resolution of such disputes. The award of the arbitrator shall be binding on both the parties. The legal jurisdiction will be the Hon'ble High Court, Kolkata.
