Dispute resolution:

Any dispute arises out of this contract the matter may first be tried to be mutually resolved by the parties (WBLDC and the successful offeror who will get the contract) amicably, failing which the matter will be referred to a sole arbitrator for arbitration in accordance with the Arbitration and Conciliation Act, 1996. The sole arbitrator will be selected mutually by both the parties. All matters in respect of this contract will come under the jurisdiction of the Calcutta High Court.

Force Majeure:

If at any time during the currency of the order / agreement, it becomes impossible on the part of bidder to comply with job schedule for reasons of war, or likely situation lawful strike and lockouts, riots, civil commotions, epidemic, pestilence, earthquakes, fire, storm or flood or any other act of god the supplier during the continuance of such contingency may not be bound to execute the contract as per order / agreement / contract. The supply shall be resumed immediately after the contingency has ceased or otherwise determined and bidder's obligations shall continue to be enforceable for corresponding extended period after the resumption of execution. TERMS & CONDITIONS FOR SUBMISSION OF TENDER

1. Tender/Auction shall be by online electronic bidding through the website of Govt. i.e. www.wbtender.gov.in. The bids can be submitted online. All interested bidder need to fill online form available on e-tender domain with necessary details.
2. The sale shall be by e-tender/auction to the **highest bidder** subject to confirmation by MD, WBLDCL in approval of competent authority.
3. Bidders can participate in the e-tender from anywhere. Therefore, the intending purchaser shall participate in the e-tender on his own behalf and no third party intervention, like authorized agent/ representative, would be permitted.
4. Bidder shall require digital signature certificate (DSC) to participate in e-tender/auction. Bidder shall have to set the parameters of his/her computer so that the DSC is operational.
5. The undersigned / NIC shall not have any liability towards bidders for any interruption or delay in access to the site irrespective of the cause.
6. In case of failure to participate in the auction by logging into the online bidding portal or on withdrawal of application prior to tender/auction, the EMD shall be forfeited, and no claim, whatsoever, would be entertained over the conduct of tender.
