### GENERAL TERMS & CONDITIONS

1. Interested Resourceful & Eligible individuals / Company/ Firms/ LLP/ Proprietorship Concerns preferably having experience in similar nature of work are eligible to participate, directly or through their sponsored entity, be it a company, firm or LLP provided they fulfil the conditions. Sponsored participating bidders must furnish authorization from its sponsoring entity.
2. The Bidder must have to register and participate online at <https://wbtenders.gov.in> and upload necessary statutory & non-statutory documents in technical folder and BOQ in prescribed format only in financial folder.
3. The period of agreement will be initially for **1 year** which may further be renewed for such further period depending upon the performance of the concern. After expiry of 1 year an evaluation will be made by W.B.L.D.C.L and on the basis of such evaluation, the **Service Charge** may be increased to such extent as may be agreed to by both the parties, Licensor and Licensee and if not agreed to the contract will cease immediately without absolving the Licensee from any liability the Licensee may have incurred during the period the Agreement was in force.

2. The contractors/bidder who have been delisted or debarred by any government department shall not be eligible in any way.
3. Bidder must submit all the statutory documents in the prescribed format (Form-I, Form-II, Form-III, Form-IV & Checklist) under the letter head of the company / firm duly sealed & signed by the authorized signatory and EMD transaction slip / exemption certificate as desired under Statutory Cover.
4. Valid up to date clearance of Income Tax Return / PAN Card / G.S.T. Registration Certificate, Trade License, Local Office / Declaration with the Technical Bid Documents to be submitted. [Non statutory Documents]
5. **Rate for all items , should be quoted for items as per Annexure-I for all items (Mandatory) .
