
Administrative Department has accorded necessary approval of revised schedule dates for organization of residential training programme involving 156 Veterinarians of different districts under ASCAD-2023-24 (WB221, 100% CSS) through WBLDCL at AARM, Haringhata.

As per the scheme guideline, it will be a programme of 2 days residential training. During the said training, 156 Veterinarians will be divided in three batches (i.e., 52 Veterinarians will be accommodated in each batch). The revised schedule of the training programme will be 19th to 20th June -2024, 21st to 22nd June -2024 and 24th to 25th June -2024 respectively for 1st, 2nd and 3rd batches. Name of Veterinarians nominated by respective DDARD&POs and their training schedule is attached as Annexure.

Accordingly, all are requested to instruct selected officers to attend the said training programme at AARM, Haringhata as per the schedule.
